Ellen read Mission Statement.

Member comments:

Pete will table at Food Stroll next. Wed.; concerned about committee structure, volunteer activity, community involvement. Says many of his acquaintance will not join until the co-op is open.

Allen's response: the store *is* open; 2 days a week.

Jim: In light of the size of the most recent UNFI grocery order, are we *de facto* "open" and therefore should be open 5 days a week?

David concurs.

Secretary's report – one new member this week. We may have hit a plateau for this stage of our development.

Nancy presented a slightly improved balance sheet. The store continues to sell more food each week, as the vendors move on to their summer commitments.

Old Business:

Maasdam coming this Thursday, Ed will have a dozen bags made up at Tee's Plus.

Kristin will staff the store in the morning; Ellen in the afternoon. 10 – 3. Much discussion about boats and out-of-towners. Eight more boats coming between now and November: July 4, Aug. 1, Sept 25, 27, 29, Oct. 17, 19, Nov 6.

Annual Meeting:

1. Pete will call no-email people to inform of meeting time and place, encourage nominations, and ask for email addresses.
2. Microphone announcements will be made on Saturdays about the meeting.
3. Meeting will be publicized on the website, the eblast, the newsletter, the front window and the bulletin board. Maybe we should hire a man on horseback, also.
