## What do you bring to the Board (experience, skills and abilities) that will contribute to Fiddleheads ongoing success?

I believe that many of the skills I utilize in my career will translate to increasing membership, as the ECSO provides a subscriber-based platform for our product, but the specifics of advising strategy to impact membership will take time for me to learn more about the organization from the inside. Similarly, the way that the ECSO stewards and cultivates our donors could inform strategy for the servant leadership model in how Fiddleheads treats its member owners. I was appointed to a Board vacancy last year and have deeply enjoyed my time with the Fiddleheads Board so far.

## What is your vision for the future of Fiddleheads during your potential three year term (and beyond!)? How would you impact this vision?

The way that I see each organization that I am involved with is that everyone's viewpoint is of value, and holds a piece of what that organization can do for the community. As a member-owned co-op, it is crucial to be sure that we are serving our members, and the overall community with the services provided. I believe Fiddleheads is and can be so much more than a grocery store, and should serve all in our community as an inclusive resource. With income disparity being a large issue in our state, Fiddleheads has the opportunity to demonstrate what equitable access looks like, and our long-term strategic vision can continue to build around the thriving community that already exists. What do you bring to the Board (experience, skills and abilities) that will contribute to Fiddleheads ongoing success?

In the context of a food cooperative, cooperation emerges through member-owners' agreement to pay for privileges of part-ownership of a local food cooperative and engage; cooperation also means growers and producers working with Fiddleheads employees and (indirectly) member owners to provide high-quality foods with an emphasis on local and organic foods at affordable prices that enable all workers in the supply chain to be paid fairly. At the highest level, cooperation in a food cooperative context means the members of the Board of Directors working with the community at large, the food cooperative management and employees, with the member-owners and with one another to learn and accomplish what is required to advance the total stated ends of the Cooperative.

### What is your vision for the future of Fiddleheads during your potential three year term (and beyond!)? How would you impact this vision?

I envision Fiddleheads improving its ability to assess the quality of its offerings, the level of engagement and satisfaction member-owners experience at Fiddleheads, its achievement of goals related to food justice, as well as to improve communication strategies and techniques between Fiddleheads' Board of Directors, its management, its member-owners and the broader New London community. In addition, I envision Fiddleheads being able to begin offering patronage payments to its member-owners. I would help to further this vision by offering my skills as a researcher, writer, photographer, justice advocate, statistician, communicator, practical philosopher, and analyst to both directly and indirectly support the Board and Fiddleheads. Naturally I would attend all meetings, maintain regular correspondence with other Board and owner-members and the broader New London community as appropriate, and attend training and networking opportunities as they present themselves.

What do you bring to the Board (experience, skills and abilities) that will contribute to Fiddleheads ongoing success?

For the past 18 years, I have served in Southeastern Connecticut on a few Boards in various capacities. Through this service, I've developed useful skills that I will contribute to Fiddleheads. At the Integrated Day Charter School, I have served on



their Foundation as the President, Vice President and Treasurer.
